Secretary Report

Minutes from 1/11/21 meeting were posted on the website. A brief/overview report was accepted by the members.

It was announced in the 1/11/21 minutes that structure changed, but the deadline for 2021-2022 dues payment was incorrect. Dues for 2021-2022 are due March 1, 2021. Any dues not submitted by April 1, 2021 will be subject to late fines.

They will conduct a request of the membership for interested parties for all executive committee positions. An email will be sent by Steve Dowling soliciting members to step forward sometime during the week of 1/25.
